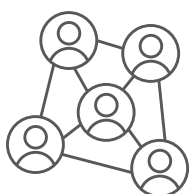
Our members contribute their rich and diverse experiences engaging with different sectors,

Join us as we seek to scale up the power of wetlands to achieve nature-based solutions!

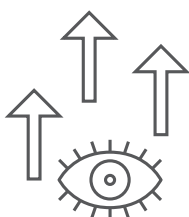
BENEFITS OF MEMBERSHIP

BECOME PART OF A LARGER NETWORK

As a member of Wetlands International Europe, your organisation gains access to a much larger network. We prioritise collaborating with others in order to leverage more impactful results and on behalf of our members, we engage in many cross sectoral platforms where we promote wetland solutions to address the urgent challenges of climate change, biodiversity loss, the degradation of freshwater ecosystems and increased societal resilience.

In addition to working with our own members, we partner with the following alliances, networks and conventions, with regional, European and international reach.

EUROPE

We are official members of European alliances such as the European Water Stewardship Network, Water Europe, European Centre for River Restoration, Dam Removal Europe, European Habitats Forum, Living Rivers Europe, Green Corridor Initiative, Mediterranean Wetlands Alliance and CONCORD. We participate as a stakeholder on the EU Water Framework Directive and Floods Directive implementation committee.

We also collaborate with the Climate Action Network (CAN) Europe, Sustainable Development Goals (SDG), Watch Europe, Joint Africa-EU Strategy (JAES), EU Civil Society Organisations (CSO), Steering Group, Eurosite, MedWet and the African-Eurasian Waterbird Monitoring Partnership.

INTERNATIONAL

Wetlands International is an active partner in the UN Decade on Ecosystem Restoration 2021-2030, as

well as the Global Peatlands Initiative. As long-time partner of the Ramsar Convention on Wetlands, our global network helps set the agenda and influences and supports implementation of the Convention's Strategic Plan. This includes a leading role in providing the underpinning scientific knowledge for wetland inventory and assessment. Our global office is also a part of international UN conventions such as the Convention on Biological Diversity, Convention on Migratory Species and the United Nations Framework Convention on Climate Change.

Wetlands International has coordinated the International Waterbird Census (IWC) since 1967, and our European office provides data management and database development for the African Eurasian flyway, which in turn bestow us with membership of the African-Eurasian Migratory Waterbird Agreement (AEWA) Technical committee.

The European Strategy is also fully aligned with Wetlands International's Strategic Intent 2020-2030, sharing a same vision, mission and ambition and will contribute to this framework by putting wetlands at the forefront of policies to solve the inter-linked crises of biodiversity loss, climate change and the degradation of freshwater ecosystems.

ROLE OF MEMBERS

Our members guide the direction of our work. By sharing expertise and working in partnership with us and our networks, members help us expand our reach and scale up wetlands solutions, from the local to regional and international levels.

We believe that the more we collaborate with our members, the more we can achieve together in reaching our goals benefiting nature and people. Our work is most successful when our members actively participate. That is why we ask our members to be prepared to invest their time and contribute to our activities and governance.

MEMBER RESPONSIBILITIES:

- Nominate up to two delegates to represent its organisation.
- Identify experts to be part of working groups.
- Attend General Members Meetings to set strategic priorities, elect the Board of the Association and approve the annual accounts.
- Engage with other members and the Secretariat.
- Connect Wetlands International Europe to strategic contacts in relevant ministries, organisations and sectors.
- Actively contribute to policy work such public consultations and position papers by providing comments and feedback.
- Share information with the Secretariat on EU engagement such as meetings and events.
- Inform the Secretariat if support is needed for strategic processes, project applications and similar opportunities.
- Review and contribute to our Strategy.
- Pay annual dues.

BECOME A MEMBER

WHO CAN BECOME A MEMBER?

Members are NGOs committed to achieving our shared goals and working together in partnership. Your organisation can become a member by demonstrating that it:

- Is a legal entity or a consortium of legal entities in their own right, registered in any state of continental Europe.
- Has a national or regional outreach.
- Carries out activities on a continuous basis, independent of any commercial, industrial or political influence or interest.
- Works in one or more areas of environmental conservation, with a main objective to preserve, restore, promote, defend and/or study wetlands-related issues.
